Fallout 76 Tricentennial Xbox One X Twitter Sweepstakes

OFFICIAL SWEEPSTAKES RULES

CHANCES OF WINNING. Fallout 76 Tricentennial Xbox One X Twitter Sweepstakes (the "Sweepstakes") is sponsored by Bethesda Softworks LLC (the "Sponsor"). Once your submission is received, you will receive one (1) entry (each an "Entry" or collectively, the "Entries") into the Sweepstakes.
