# Fallout® 76 E3 2018 Custom Xbox One X Sweepstakes

# **OFFICIAL SWEEPSTAKES RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. Fallout® 76 ("Fallout 76") – E3 2018 Custom Xbox One X Sweepstakes (the "Sweepstakes") is sponsored by Bethesda Softworks LLC (the "Sponsor"). For the purposes of the Sweepstakes, the "Sweepstakes Group" is composed of the Sponsor, together with its affiliates and related companies, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective officers, directors, employees, agents, and other representatives.

# 1. SWEEPSTAKES PERIOD

(ii) "Like" the official Fallout contest post with a comment saying what your favorite news about Fallout 76 is.

# **To Enter on Instagram:**

- (i) Follow the official Fallout Instagram page and "LIKE" the official contest post located at (https://instagram.com/Fallout); AND
- (ii) Comment on the official contest post telling us your favorite news about Fallout 76.

No other method of entry will be accepted.

Once your submission is received, you will receive one (1) entry (each an "Entry" or collectively, the "Entries") into the Sweepstakes. By submission of an Entry, you confirm that you have read, understood and agree to abide by these Official Sweepstakes Rules. Your submission must adhere to the Eligibility Criteria listed above or your submission will be void and ineligible for entry into the Sweepstakes. You represent and warrant that your submission is not libelous, defamatory, profane, or obscene and does not infringe upon the intellectual property rights, rights or privacy or personality or any other statutory or common law rights of any other person.
