

12 Days of Bethesda® – Holiday Sweepstakes

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. **12 Days of Bethesda® – Holiday Sweepstakes** (the “Sweepstakes”) is sponsored by Bethesda Softworks LLC (the “Sponsor”). For the purposes of the Sweepstakes, the “Sweepstakes Group” is composed of the Sponsor, together with its affiliates and related companies, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective officers, directors, employees, agents, and other representatives.

1. SWEEPSTAKES PERIOD

The Sweepstakes starts on **Thursday, December 13th, 2018** at approximately **11:00 a.m.** Eastern Standard Time (“EST”) and ends on **Monday, December 24th, 2018** at **12:59 p.m. EST** (the “Sweepstakes Period”).

2. ELIGIBILITY

All participants must be 18 years of age or older at the time of entry, must possess a valid form of identification and be a legal resident of one of the 50 United States (or the District of Columbia),

excluding the territories, military installations and commonwealths. All applicable federal, national, state, and local laws and regulations apply. Void where prohibited, restricted or taxed by law. Excluded from eligibility are officers, directors, employees, agents and representatives of Sponsor, each of its respective parent, affiliated or related companies, agencies, suppliers of the materials and services related to this Sweepstakes, and members of any immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and sales representatives.

3. HOW TO ENTER

NO PURCHASE NECESSARY. **Enter via Twitter:** Internet access and Twitter account required.

Each day during the Sweepstakes Period, Sponsor will Tweet a picture of a Sponsor game-related prize giveaway for that day along with the hashtag #12DaysofBethesda via its Twitter account @Bethesda (the “Daily Sweepstakes Tweet”). To enter the Sweepstakes, log into your Twitter account and “Follow” the Bethesda game account tagged in the Daily Sweepstakes Tweet (@Bethesda, @DOOM, @Quake, @preygame, @RAGEgame, @Fallout, @dishonored, @ElderScrolls, @TheEvilWithin, @TESOnline, @wolfenstein, or @TESLegends,). Then, retweet the Daily Sweepstakes Tweet by 12:59 p.m. EST the following day to receive one (1) entry into the Sweepstakes. In order for your entry to be valid, your Twitter Account must be public and thus viewable by the Sponsor and its agents.

Once your submission is received, you will receive one (1) entry (each an “Entry” or collectively, the “Entries”) into the Sweepstakes. By submission of an Entry, you confirm that you have read, understood and agree to abide by these Official Sweepstakes Rules. You must satisfy the eligibility requirements listed in Section 2 above or your submission will be void and ineligible for entry into the Sweepstakes.

You represent and warrant that your submission is not libelous, defamatory, profane or obscene and does not infringe upon the intellectual property rights, privacy or personality or any other statutory or common law rights of any other person. Limit: One (1) Entry per person per day during the Sweepstakes Period. Entry must be submitted by the entrant him or herself. You may only use one (1) Twitter account in connection with this Sweepstakes. Any attempt to exceed the maximum number of Entries per person is a violation of these Official Sweepstakes Rules and may result in disqualification. Use of automated devices is prohibited; automated Entries (including but not limited to Entries submitted using any robot, script, macro or other automated service) are not permitted and may result in disqualification. Limit: One (1) prize per person.

4. HOW TO WIN THE SWEEPSTAKES

At approximately **12:59 pm EST** each day between Friday, December 14th, 2018 and Monday, December 25th, 2018, a random draw will be conducted from all eligible Entries received via Twitter since the previous day's Daily Sweepstakes Tweet was posted (the "Draw Dates"). See Prize Claim Conditions in Section 5 below. Odds of being selected as eligible to win a prize in this Sweepstakes will depend on the total number of eligible Entries received each day during the Sweepstakes Period.

5. PRIZE CLAIM CONDITIONS

The selected entrants in the Sweepstakes will be notified by Sponsor within approximately forty-eight (48) hours of the respective Draw Date(s) via the Twitter account used by the entrant to submit the Entry. Selected entrants may also be required to complete and return to Sponsor (or its authorized agent) by the deadline specified in the documents a written affidavit of eligibility (or declaration and release) and publicity release form (collectively, the "Release"), releasing the Sweepstakes Group from any liability in connection with this Sweepstakes or the acceptance, possession, use or misuse of any prize. Return of any prize or winner notification as undeliverable, inability to reach selected entrant or failure of selected entrant to respond to notification within three (3) days of first attempt by Sponsor or Sponsor's agent, failure to provide proof of eligibility (if requested), Release documents, or other required documentation in a timely manner, or other non-compliance with these Official Sweepstakes Rules may result in disqualification, forfeiture of the prize and, at Sponsor's sole discretion, selection of an alternate eligible entrant for the forfeited prize at random from all remaining eligible Entries received, who will be subject to disqualification in the same manner. With respect to the Sweepstakes the winner of any one drawing is ineligible for another drawing.

6. PRIZES

There will be twelve (12) winners. Each winner will receive a prize(s) consisting of a Bethesda game and/or game-themed authorized collectible(s), that will be displayed in the Daily Sweepstakes Tweet from the day that each selected entrant is selected. Selected entrants will be provided with a written description of the Bethesda related prize(s) they have been selected for and of the approximate retail value of the prize(s) prior to being required to accept the prizes, which shall not exceed \$500 per prize(s).

The Prizes will be delivered only to verified winners by January 31st, 2019. ARVs determined as of December 2018. Prices are subject to change; retailers may sell for less. Prizes must be accepted as awarded and may not be substituted, transferred or redeemed for cash or otherwise; however, the Sweepstakes Group reserves the right to substitute a prize of equal or greater monetary value, in cash or

otherwise, at its sole discretion, if a prize, or any component of any prize, cannot be awarded for any reason. Sponsor will not replace any lost or stolen prizes. Sponsor makes no representations or warranties with respect to any prize. Prizes include delivery to U.S. addresses only, as supplied by selected winners.
