

Fallout® 4 Free Weekend - Signed Custom Console Twitter Sweepstakes

OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. **Fallout®4 (“Fallout 4”) Free Weekend – Signed Custom Console Twitter Sweepstakes** (the “**Sweepstakes**”) is sponsored by Bethesda Softworks LLC (the “**Sponsor**”). For the purposes of the Sweepstakes, the “Sweepstakes Group” is composed of the Sponsor, together with its affiliates and related companies, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective officers, directors, employees, agents, and other representatives.

1. SWEEPSTAKES PERIOD

The Sweepstakes starts on **Thursday, May 25th** at approximately 11:00:00 a.m. Eastern Daylight Time (“EDT”) and ends on **Sunday, May 28th** at 10:59:59 a.m. EDT (the “**Sweepstakes Period**”).

2. ELIGIBILITY

All participants must be 18 years of age or older at the time of entry, must possess a valid form of identification and be a legal resident of (i) one of the 50 United States (or the District of Columbia) excluding the territories, military installations and commonwealths or (ii) Canada. All applicable federal, national, state, provincial and local laws and regulations apply. Void where prohibited, restricted or taxed by law. Excluded from eligibility are officers, directors, employees, agents and representatives of Sponsor, each of its respective parent, affiliated or related companies, agencies, suppliers of the materials and services related to this Sweepstakes, and members of any immediate families (defined as parents, siblings, children and spouses, regardless of where they live) or households (whether or not related) of such officers, directors, employees, agents and sales representatives.

3. HOW TO ENTER; REPRESENTATIONS AND WARRANTIES; OWNERSHIP OF SUBMISSIONS

NO PURCHASE NECESSARY. Internet access and a valid Twitter account required. To enter the Sweepstakes, entrant must

(i) **Follow official Fallout Twitter account used to submit the entry**, located at (<https://twitter.com/Fallout>)

(ii) **Retweet the @Fallout tweet that references the Custom Fallout 4 console giveaway** during the Sweepstakes Period (the “**Submission**”). **You can also enter by tweeting your favorite Fallout 4 destination with the official hashtag #Fallout4FreeWeekend.**

No other method of entry will be accepted.

Once your submission is received, you will receive one (1) entry (each an “Entry” or collectively, the “Entries”) into the Sweepstakes. By submission of an Entry, you confirm that you have read, understood and agree to abide by these Official Sweepstakes Rules. Your submission must adhere to the Eligibility Criteria listed above or your submission will be void and ineligible for entry into the Sweepstakes. You represent and warrant that your submission is not libelous, defamatory, profane, or obscene and does not infringe upon the intellectual property rights, rights or privacy or personality or any other statutory or common law rights of any other person. Limit: One (1) Entry per person per entry method during the Sweepstakes Period. Entry must be submitted by the entrant him or herself. Entrant may only use one (1)

Twitter account in connection with this Sweepstakes. Any attempt to exceed the maximum number of Entries per person is a violation of these Official Sweepstakes Rules and may result in disqualification. Use of automated devices is prohibited; automated Entries (including but not limited to Entries submitted using any robot, script, macro or other automated service) are not permitted and may result in disqualification.

4. HOW TO WIN

On or about **June 1st, 2017** (the “**Draw Date**”) in Rockville, Maryland, a is one (1) prize available to be won. See Prize Claim Conditions in Rule 5 below. 5. PRIZE CLAIM CONDITIONS

The Prize will be delivered only to a verified winner. ARV determined as of May 19, 2017. Price is subject to change; retailers may sell for less. Prize must be accepted as awarded and may not be substituted, transferred or redeemed for cash or otherwise; however, the Sweepstakes Group reserves the right to substitute a prize of equal or greater monetary value, in cash or otherwise, at its sole discretion, if a prize, or any component of any prize, cannot be awarded for any reason.
